#### **Financials**

- Budget
  - The budget is mostly complete, with some fine tuning. As referenced in the last meeting, I recommend the Board has a separate meeting next week to make decisions about the budget and staffing, given revenue unknowns.
  - Current FY still on track with previous two projections.
  - Notable: Richardson Bay Sanitary District annual sewer charge: \$17,468\*
    - Previous years:
      - 2016 \$3,200
      - 2017 \$6,900
      - 2018 \$5,300
      - 2019 \$6,100

## Furlough

o Current furlough for employees extended through June 3, 2020.

#### Facilities:

- The south entrance gym doors are being fitted with the new ADA push bars and hardware now. Anticipated installation is tentatively set for June 8-9. Vendor was unable to retrofit existing hardware to current codes. Adds an additional \$3400 to cost of the four doors.
- The Snack Shack painting was completed last week and looks great. It is very complimentary with the pool deck colors. Lifeguard office and shower shed will be painted to match.
- The final changing station is completed and will be ready for patrons when we are back to more normal use of our Aquatics Facility

## **COVID -19 Updates:**

- The Sanitation Specialist job position has been created and posted on job sites. We are actively looking for one full-time, or two part-time employees for help attain consistent sanitation of the facility.
- We have purchased and are waiting on the delivery of twelve hand sanitizer stations and twelve disposable sanitary wipe dispensers. They will be strategically placed at the buildings, aquatic facility and tennis courts. A weather resistant enclosure will be constructed for them and signs will provide a description of their use.
- Thermal scan thermometers should arrive this week

### **Athletic Fields:**

• True North Landscapers will be installed an additional (4) cubic yards of cinder on May 21<sup>st</sup>. This has brought the entire infield back up to grade for the first time in three seasons.

### **Aquatics:**

- The heaters for the Main Pool, Teaching pool and Wader were turned back on Tuesday, May 26<sup>th</sup>. We anticipate all bodies being up to heat by Friday the 29<sup>th</sup>.
- We are getting pricing from Watershape to address suction flow issues that have been a concern since the splitting of the main drains. The split of the drains was required by Marin EDH Inspector as part of the pool resurfacing.

#### Parks:

- We've been experiencing fairly consistent vandalism and removal of signs and caution tape from the parks. This has been pronounced at Harbor Cove and Brickyard park. Over the Labor Day weekend, both had an inordinate amount of debris throughout the parks.
- We're installing a new bollard at the entrance to Brickyard by June 3<sup>rd</sup>.
- UC Davis student Julia Gonzalez will be performing research at Brickyard focused on the impacts of invasive European green crabs in San Francisco Bay.
- True North Landscapers will be performing all park rough mowing and vegetation management from June 8<sup>th</sup>-12<sup>th</sup>.

### Camp Strawberry

- Plans are underway to reformat camp into three 3-week sessions
- This week, we will start contacting registered campers to give the priority to enroll in the new format. First priority registration email went out this afternoon.
- We have a waiting list for campers not yet registered.
- We have part time staff working on creating the necessary forms, guidelines and protocol as well as camp activity schedules.
- The first session begins on June 15<sup>th</sup> and can accommodate up to 48 campers. Each group of 12 campers will have two counselors and possibly up to two CITs (TBD).
- We are working to make sure we set up camp to conform to Marin HHS guidelines for health and safety
- As referenced above, we are accepting applications for Sanitation Specialist to sanitize our facility as required by the camp guidelines.
- We are purchasing the necessary supplies to get camp up and running

### **Aquatics Facility Reopening**

- Waiting on guidance from Marin HHS
- Sent survey to 1,071 SRD Patrons
- As of 5/27 257 responses
  - o 50% pool pass holder
  - o 32% not pass holder
  - o 18% planning to purchase a pass when pool reopens
  - o 91% planning to use the pool when it reopens
    - More in next report
