



Aquatics Facility Guest Pass Rules, Sign- In Agreement, Waiver, and Release

Guest Fees:

\$10 per person, \$25 total for up to 4 guests. 4 guest maximum per membership. Cash or check only at gate. If you do not bring cash or check, members account will be charged.

- **Guests must be accompanied by a pool pass member who is 18 yrs. or older.**
- **ALL CHILDREN 6 AND UNDER MUST BE ACCOMPANIED BY A PARENT IN THE WATER.**
- **All children not potty trained must wear a swim diaper.**
- **Swim diapers available in the aquatic's office - \$5.**
- **All guests must sign-in and pay at gate.**

In consideration for being permitted by the above district to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity.

This release is intended to discharge in advance the above district (its officers, employees, and agents) from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of active or passive negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume indemnify and to hold the above person or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activity.

This release includes claims for damages resulting from the Coronavirus/Covid 19 and by signing this I understand that Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in SRD programs or accessing SRD facilities could increase the risk of contracting COVID-19. SRD in no way warrants that COVID-19 infection will not occur through participation in SRD programs or in accessing SRD facilities.
