  - Vanguard also did a deep clean in gym kitchen and building bathrooms (asses every 6 months)
  - Working with Landesign to get bids for spring field prep
  - Loft retaining wall collapsed. Hired contractor to remove debris and put plastic & sandbags in place until we can start construction on new wall
  - Hazardous material CERS report completed -
    - Need to complete training prior to inspection
  - Security camera issues resolved by CSC
    - New components not needed, was a programming issue

### Aquatics

- Q1 2023 Pool Passes went on sale 11/29/2022 and sold 143 Primary Memberships.
- Finalized and created the winter swim lesson schedule. Opened for online registration on December 14.
- Although not completely sold out, we had decent numbers for winter session. Selling just over \$20,000 for a 6-week session.
- Confirmed all aquatic staff have completed both Sexual Harassment and Child Abuse trainings.
- Drained more than 60% of the main pool and refilled with fresh water over the Christmas break.
   Starting TDS (total dissolved solids) was 9,500 and reopened with TDS of 4,350.
- Drained 80% of the teaching pool and refilled with fresh water. Starting TDS was 8,900. Current TDS is 2,900.
- Tested Alkalinity and Calcium levels and added dry chemicals before reopening.
- Ran Aquatic Staff In-Service meeting on 01/04/22. 17 staff members attended. Went over CPR, pool rules, schedule, expectations.
- Fired heaters back on with Bart. Bart found problem with heater #1. Ordered parts and waiting for them to come in. Estimated repair time Friday, 1/13
- Ran backwashes on all bodies of water.
- Cleaned skimmer baskets on deck and in pump room.
- Cleaned entire pool deck and inside pool on opening day 01/09/23.
- Pool Scene came out on 1/5/23 to check pool chemicals and add Conditioner to pool.
   Conditioner helps keep chlorine in the pool longer.
- All of January schedule drafted and posted by Trinity.
- Lifeguard recertification class scheduled for February.
- Beginning to draft and create Spring swim lesson schedule. Spring lessons to go on sale first week of February and begin February 27.
- Teaching pool underwater lights need to be replaced by pool scene in the coming week.
