



- 2. Applicants must include verification of eligibility and residency information. Please submit copies only, as documents will not be returned to the applicant.
- 3. If there are more applications than funds available, SRD will conduct a lottery to determine the selection process.
- 4. Funds will be applied to programs and applicants will be required to pay the remaining balance to be fully enrolled.
- 5. Funds do not have a cash value and will not be reimbursed or paid to applicant. If the program applicant is enrolled in is canceled, funds will be available to apply to future programs.
- 6. Identity of applicant and family members will be kept confidential.
- 7. Scholarships must be used within a 6-month period of being awarded. Funds not used in this timeframe will no longer be available to applicants and be returned to the scholarship fund.
- 8. Applications are accepted throughout the year and awarded on a rolling basis as long as funds remain available.
- Income: Applicant's household and/or supporting parents, must have an income equal to or less than the very
 low-income level from State Income limits, Department of Housing and Community Development. For 2022, the

Fund Allocation

Applicants living outside these areas are not eligible for the SRD Scholarship Program

Distribution of Scholarship Funds

- 1. Funding will be provided for programs conducted by SRD staff Summer Camp, Play Club, and Swim Lessons.
- 2. Funding will be at 50% of a program, up to \$200 per individual per calendar year, with a maximum of \$600 per family per year.
- 3. Funds are not transferable.
- 4. Funding does not cover material or supplies, programs taught by non-SRD employees, rentals & security deposits, memberships, activities, events, or drop-in fees.

Facilities

Facilities

- Lavish Audio has completed the installation of the new gym sound system, and after a couple minor glitches we got it dialed in on 5/1
- The overgrown shrubs and trees at the front entrance have all been brought down to 9', which will improve our view of the coastal cypress and screening from the street.
- All the gutters, flashing and downspouts on the main building were painted to improve the
 aesthetic by making them blend into the existing color scheme.
- We've replaced the old sanitation stations throughout the site with new Purell easy pump dispensers, that both look better and are easier to use.
- The General Manager's office has been completely reoriented and redesigned to improve flow and light.
- The 1st Floor Meeting Room heater failed in January, and Downing heating is searching for replacement pieces. However, the unit is antiquated, and if parts aren't acquired then replacement may be necessary.
- The Monterey Pine above Reggie Park was removed on April 10th, and the interior live oak on the slope behind court 4 – was removed on April 12th.
- This week (5/8), work is scheduled to begin on the 3rd floor retaining wall. The contractor was delayed due to emergency flood work.

Athletic Fields

- Martin Bros completed the field renovations on 4/4. Since then we've received a lot of positive patron feedback about the quality of work, and improved play on the infield diamonds.
- A mainline leak was found in the minors field on 5/3; Landesign to fix the week of 5/8.
- The Spring Fertilization of the entire field occurred on 4/2.
- We are prepping the bleachers for sanding and repainting. The existing Bear Brown color looks dated, so we've chosen a dark grey/ blue (Midnight Blue) as the new bleacher color.

Aquatics / Water

- Adams Pool Solutions has completed the demolition and tiling phases of the spa renovation, and
 it's tentatively scheduled to perform the plastering on May 19th. After the spa work is complete,
 the last phase of the project is to test the heater. If it works then we will be set to go. If not, we
 will either repair or replace the heater.
- Two new Intelliflow pool pumps were installed for the spa, so the water circulation can now be controlled remotely from staff phones.
- A new baby changing station has been installed in the ADA bathroom on the pool deck.
- We've purchased a new pool robot, and pool blaster to replace the malfunctioning units. The new unit is working well so far and can be remotely operated through a phone app.

Parks

- The dock gangway at Harbor Cove Park has sustained moderate damage during the December storms. We're looking to contract with Lind Marine to address the issue this spring.
- After 35 years the property manager for DeSilva Island retired in April. On May 5th, we met Carol
 and Jake, the new property manager and on-site engineer respectively.
- We've received a T&M proposal from Landesign to perform the spring rough mow of the parks for \$10-12k. If approved, the work will be scheduled for late May.
- Many trees and branches fell during recent storms in March and April, all items have been removed, except for a couple piles of logs at Brickyard.

Aquatics

- SRD purchased new CPR training materials, including new AEDs and adult/child dummies.
- Brittney and Trinity had a very successful lifeguard class on April 14-16. The class ran very smoothly. The next lifeguard class is scheduled for June 2-4, and is sold out.
- Spring B Swim Lessons sold out quickly and are running smoothly. The session is 6 weeks long.
 Sold \$23,000 in lessons.
- Summer swim lessons go on sale, Tuesday, May 23 at 10:00am.
- All lessons are entered in RecDesk. We will be offering a total of 161 lessons. (Summer 2022 we offered 136)
- Trinity and Brittney are processing Camp swim lesson assessments and placing campers in the most optimal swim level to start their summer camp swim lessons.
- Q2 Pool Passes \$89,900 revenue. We are still offering pro-rated pool passes for the remaining 7 weeks of the pass.
- Q3 Pool Passes will go on sale June 6 @ 10am and valid June 27 September 24, 2023
- Trinity and Brittney have processed returning summer staff and hired 5 new summer aquatics staff. New hire training will take place in the month of May, so all are ready to begin June 12.
