## FIRST ADDENDUM TO THE EMPLOYMENT AGREEMENT BY AND BETWEEN THE STRAWBERRY RECREATION DISTRICT AND NANCY SHAPIRO

THIS ADDENDUM is made and entered into on the <u>8</u> day of <u>August</u>, 20<u>23</u>, by and between the STRAWBERRY RECREATION DISTRICT and NANCY SHAPIRO.

### Recitals

WHEREAS, the STRAWBERRY RECREATION DISTRICT BOARD OF DIRECTORS ("STRAWBERRY" OR "BOARD") and NANCY SHAPIRO (collectively, "the Parties") entered an Employment Agreement ("Agreement") on June 13, 2022 to employ NANCY SHAPIRO as the General Manager for STRAWBERRY, pursuant to California Public Resources Code section 5786.1; and

WHEREAS, the Agreement has a two-year term; and

WHEREAS, based on NANCY SHAPIRO'S performance over the past year, the Parties now desire to amend the Agreement;

NOW, THEREFORE, the Parties agree to enter a First Addendum to the Agreement to modify NANCY SHAPIRO'S compensation as set forth below.

### Agreement

- 1. Except as otherwise provided herein, all terms and conditions of the Agreement shall remain in full force and effect.
- 2. The Employment Agreement is hereby amended as follows:

Section III of the Agreement is amended to read as follows:

NANCY SHAPIRO shall receive an annual salary of \$160,000, effective July 1, 2022.

Effective July 1, 2023, NANCY SHAPIRO shall receive a cost of living adjustment ("COLA") of 3% and a merit-based increase of between 1% and 5%, at the discretion of STRAWBERRY.

#### **Facilities**

#### Facilities:

- The third-floor ramp railing posts have been filled and stained, as well as caps added for improved longevity.
- Performed full cleanup and tree pruning of the burn area where the Porto-potty was set on fire.
- Installed new camera to view parking lot ramp & porta potty area
- Ordered and assisted with installation of a new smaller Porto-potty and entrance platform at the corner of the majors right field.
- Tested Reggie Park camera and determined that it needs a Wi-Fi extender. We're working with Fusion to determine the right setup and hope to have it installed by the end of July.
- Work on shoring up the 3<sup>rd</sup> floor deck with support beams has started.
- We ordered and tested three new large popup tents for Community Night and other large events.
- Full time staff sign poles are being installed in front of (7) parking spaces in the southwest corner
  of the lot.
- Facilities assisted in the set-up and layout of the 1<sup>st</sup> floor camp room and gym stage.

#### Athletic Fields:

- All three minors field bleachers have been fully refurbished. The metal frames were painted black, and the seats were painted midnight blue.
- The four benches along Belvedere have been refurbished to match the new look of the minor's field bleachers.
- We're garnering bids from bleacher contractors to install a fourth section of bleachers, and replace the existing wood seat with composite boards.

#### Aquatics / Water:

- We tested the spa and determined water loss is occurring. We've contacted several leak detection companies to get pricing and move forward with locating the leak.
  - More testing was done while spa not in use
  - Turning spa off at night to see if it helps reduce evaporation and water loss
- Backwash tank and sump pump are scheduled for cleaning on 8/15
- Replaced one leaking pump motor for spa jet #2 on 8/4

### Aquatics

- Summer swim lessons have been very successful. We have had plenty of instructors to teach the
  most lessons we have offered over a summer session.
- Family/Rec Swim was extended all summer to allow "Dop-in" swim for members without reservations M-F 1pm – 6pm.
