REQUEST FOR PROPOSAL

Third Floor Deck Repair and Refurbishment

Purpose of the RFP:

This Request for Proposal (RFP) is issued by the Strawberry Recreation District (hereinafter referred to as "SRD") acting through the SRD Board of Directors. The purpose of this RFP is to establish a contract with a qualified vendor for **the Repair and Refurbishment of the existing deck, benches, railing and joists in kind**. The resulting contract from this RFP will provide design, installation, and clean-up proposal to the SRD.

Project Description:

1. GENERAL

- A. Provide pricing for all aspects of construction, as well as as-builts for the Installation and repair of all materials.
 - a. Deck/ Bench Material
 - i. ipe wood
 - ii. composite Ex: Trex, Timber Tech or like products
 - b. Railing post will be removed and replaced with metal posts; existing rail will be removed and reinstalled after
 - c. Joists can be reused if dry rot is not too bad, otherwise the joists will have to be replaced in kind



- B. Pricing shall include all permits, mobilization, traffic control (if necessary) and removal of spoils and debris generated by the project.
- C. Each qualified bidder / proposer must submit its proposal with the cost proposal and all cost information in a separate, sealed envelope (PCC § 10344).
- D. Payments are subject to payment withholds, and/or penalties for late, or inadequate performance.
- E. Anticipated contract term, including commencement and completion dates are:
 - 1. Work to begin on Oct 1st 2025
 - 2. Work to be completed ASAP

2. DELIVERY, STORAGE, AND HANDLING

- A. Delivery and Acceptance Requirements: Deliver materials to site in manufacturer's original, unopened containers and packaging, with labels clearly identifying product name and manufacturer.
- B. Storage and Handling Requirements: Store and handle materials in accordance with manufacturer's instructions.
- C. Keep materials in manufacturer's original, unopened containers and packaging until application.
- D. Store materials in clean, dry areas indoors, out of direct sunlight.
- E. Protect materials during storage, handling, and application to prevent contamination or damage.

Construction Window:

This is a prevailing wage project. All contractors must be licensed in California, have a current DIR number, be bonded and insured.

All subcontractors will also be required to pay prevailing wage.
